

UK Visitor Visa Documents Checklist

India to UK Visitor Visa application

1) Valid Passport

- Current passport
- Old passports (if any)
- Previous visa stamps (if applicable)

2) Digital Photograph

3) CA Report

4) Property valuation report

5) Bank Statements

- Last 3 months bank statement (stamped)
- Bank balance certificate

6) Education Documents

Last education certificate (degree/12th etc.)

7) Personal Documents

Aadhar Card (Applicant & Family)
Marriage Certificate (if married)

8) Previous Visa Refusal Letter

- If refused by any country earlier

9) If Someone Is Sponsoring You

- Support affidavit

If Applicant is Working (Employee):

- 1. Job / Employment Letter**
- 2. Leave Approval Letter / NOC**
- 3. Salary Slips**
 - Minimum last **3 months' payslips**
- 4. Bank Statement**
 - Last 3–6 months reflecting salary credits

If Applicant is a Student (India to UK Visitor Visa)

1. **Admission Letter**
2. **Student ID Card**
3. **Bonafide Certificate**
 - Letter from institution confirming enrollment
4. **Leave Permission Letter / NOC**
 - From college (mentioning travel dates)
5. **Semester Transcripts / Mark Sheets**
 - Latest semester result
6. **Fee Receipt**
 - Proof of paid tuition fees (if available)
7. **Pay Slips (If Part-Time Working)**
 - Last 3 months salary slips (if student is working)

If Applicant is Self-Employed / Business Owner

(For UK Visitor Visa – UK Visas and Immigration)

Business Documents Required:

1. **Business Registration Proof**
 - Trade License / Firm Registration Certificate
 - MSME / Udyam Registration
 - GST Registration Certificate
2. **Business Letterhead**
 - Self-declaration letter on company letterhead mentioning:
 - Nature of business
 - Since when operating
 - Confirmation of travel dates
3. **Visiting Card**
 - Business visiting card copy
4. **Business Supporting Documents (Any Available)**
 - Receipt book copies
 - Sale/Purchase invoices
 - Rent agreement of shop/office

- Shop & Establishment certificate

Required Documents from Sponsor (UK)

Identity & Immigration Status

1. Passport Copy

- Bio page
- UK visa vignette / entry stamp

2. E-Visa / BRP Status

- E-Visa copy
- Share Code (for immigration status verification)

3. Right to Work Proof

- Screenshot / confirmation (if employed in UK)

4. UK ID (If Available)

- BRP card (if issued)
- Driving Licence (optional)

Financial Documents

5. Bank Statements

- Last 3 months (minimum)
- Showing sufficient balance

If Sponsor is working

6. Job Letter

- On company letterhead

7. Pay Slips

- Last 3 months

If Sponsor is a Student

8. CAS Letter

- From university

9. Student ID Card

Address / Residency Proof

10. Residence Proof

- Tenancy agreement
- Utility bill
- Council tax bill (if available)

Invitation Documents

11. Invitation Letter

- Mention relationship
- Purpose of visit
- Duration of stay
- Accommodation details
- Who will bear expenses

For a **tourist visa**, **sponsor documents are generally NOT required**. It is usually a **self-funded application**.

Commonly accepted documents are:

- Dummy hotel booking
- Ticket booking dummy
- Travel itinerary
